## **Bunbury Car Club Inc - Code of Conduct**

Please read the following before signing

- 1. No Person should bring the club into disrepute.
- 2. All members will follow rules set by the committee at race meetings or events.
- 3. No person shall make rude or derogatory gestures or direct verbal abuse to another person
- 4. The Abuse of any official of the Association will not be tolerated at any time either before, during or after a race meeting.
- 5. No person shall approach an official of the meeting with the intent of interfering in the duties of that person. This does not include offers of assistance of a non-decision-making matter.
- 6. No person shall drive in a dangerous manner anywhere within the confines of the speedway which shall include the areas immediately outside of the speedway.
- 7. All persons shall observe barricades and signage in place and shall not breach any unless permitted to do so.
- 8. Post no negative comments or slander regarding Bunbury Car Club, Bunbury Speedway, drivers, officials, or events that take place at Bunbury Speedway via any social media platforms.
- 9. No person shall approach a driver's pit area, unless in a friendly manner.
- 10. Have the correct insurance and car paperwork to enter events. (Drivers & Car Owners)
- 11. All persons entering the Pit Area shall sign the waiver form at the Pit Gate, Pay the necessary fees and obtain a wrist band which will be worn at all times when in the pit area.
- 12. Any person entering the Pits must have appropriate insurance that allows entry to the Pit Area. Children under the age of 12 years are not permitted in the Pit area unless actively competing in the race event.
- 13. One Day Pit License are only available online with Speedway Australia. (All details to legible and correct)
- 14. Any person attending the bar area during the race meeting shall surrender their wrist band and not be permitted to re-enter the pits for the remainder of the race meeting.

Any person accused of any breach of the above will be dealt with by the management committee of the Bunbury Car Club. The management committee reserve the right to penalize any person for breaching the code of conduct as it sees fit. Penalties may range from a caution, through to removal of membership.
